The Lake Township regular meeting was held on Monday, March 11, 2024 at the Lake Township Municipal Building.

Minutes were read and approved by a **motion** from Fairlamb 2nd by Gander

Chairman Elder recognized Mr. Zahnhizer from the Little League. The Supervisors asked about the work still needing done at the Jack Jones Memorial Complex by the Little League that was already approved. Mr. Zahnizer stated that they still plan on doing the work and will get it completed soon. There was a discussion about the grant application from the county. Mrs. Yarnell will reach out to see where we are with that as the new commissioners have taken over. The Little League is involved in several grants, however none of that if received would go to the Jack Jones Memorial Complex. The League is not willing to put money into the park for fear that LARA will take back over and that they do not have control over scheduling. The Township reminded them that they have used the park for several years at no charge and that the Township officially notified LARA that their management services are terminated. The Township also stressed the fact that anyone outside of the Little League that has inquired about using the field has not actually used it. The Little League when approached about these possible times has always cooperated with the Township. Financial support could possible be something the Little League could do in the future. A request for a port-a-john was made and the Township will have one delivered asap.
