The Lake Township regular meeting was held on Monday, July 8, 2024 at the Lake Township Municipal Building.

Minutes were read and approved by a **motion** from Fairlamb 2<sup>nd</sup> by Gander

No public comment on the Solar Panel Ordinance.

**Motion** to adopt the Solar Panel Ordinance from Fairlamb 2<sup>nd</sup> Gander

Chairman Elder recognized guests Dave Hoobler and Natalee Conway. Dave wanted to ask that Lake Township apply for the Multimodal grant from DCED as New Vernon Township declined to write the grant. Secretary Deanna Yarnell had declined to write the grant but would help in anyway prior and had been working with Natalee from H&H. Natalee is not confident in writing the grant. Mrs. Yarnell is skeptical that the grant can be completed by the upcoming deadline of July 31<sup>st</sup> 2024, but if there is no one else to write the grant she will do it. Deanna and Natalee have both been in contact with Jamie Lineman from PennDot. Natalee is confident he will have all the figures ready this week. Deanna will contact Dan Gonz with Gannet and Fleming the Township Engineer to put together the necessary documents for the grant. The estimated total for the grant could be over 2 million dollars for both Municipalities. Deanna has already reached out to Senator Brooks and Representative Bonner's offices for letters of Support and will contact the DCED about the online application. Mr. Hoobler stresses the importance of this substantial upgrade taking the Township dirt and gravel road to a paved road. The Supervisors agree that although this maybe desired the Township has no funds to commit to this project. The Multimodal DCED Grant has the provision to allow both Municipalities to claim that the project is a financial burden releasing them from a 30% match. Mrs. Yarnell and Ms. Conway will meet

this week and try to get the New Vernon Secretary involved.

**Motion** to approve Resolution 2024-01 to enter into a Multimodal Grant from DCED for Paving improvements to Canon Road to Billy Boyd Road by Fairlamb  $2^{nd}$  by Gander.

The Township received a \$20,000.00 Grant from the County Commissioners for the Jack Jones Memorial Complex. The Township will reach out to Sedon Well service about the water well and the Power company to get the electric service in. Fred Elder has been contacted about moving the dirt at 217 Lake Hill Road that LARA moved their when fields A, B, and C were first started. He will begin to move that dirt this week, this dirt can be used in finishing field C.
